TRACKING TEST AWARD

A wooden initial will be given to each handler & dog team that passes the Tracking Dog test.

IMPORTANT NOTES TO EXHIBITORS

ELIGIBILITY: With the entry form for a dog that has not passed an AKC Tracking Test, there must be filed an original statement dated within 1 year & signed by a person who has been approved by the AKC to judge tracking tests (or Provisional Tracking Judge), or has had a title within the past 10 years certifying that the dog is considered ready for such a test.

TEST LIMIT & DRAW: This test is limited to 4 VST/2 TDU dogs. Entries will remain open until WEDNESDAY, 10/5/22 until 5:00 p.m. If entries received exceed the test limit, a public drawing will be held WEDNESDAY, 10/5/22, at 6:00 p.m. at BSKD 2980 W. Oxford Ave, Sheridan, Colorado. Any interested parties may attend. If alternate entries remain after the draw, an additional draw will be conducted to determine the order in which alternates will run. In all cases, preference will be given to Pembroke Welsh Corgis first, followed by all other breeds. The test secretary will attempt to contact all entrants by phone or email, and advise of the outcome of the draw within 48 hours. Notification of the results of the draw will be mailed to all entrants as soon as practicable. The provisions of Section 13a and 13b, Chapter 1 of the AKC Tracking Regulations will be invoked. The test will be open to all breeds under the following conditions: Preference in the draw will be given first to Pembroke Welsh Corgis without a title, followed by Pembroke Welsh Corgis with a title, followed by other breeds without a title, followed by other breeds with a title.

ENTRY FEE: \$140.00/\$75.00 (in US dollars). (This includes the 50 cent AKC recording fee & the \$3.00 AKC Event Service Fee.) Make checks payable to PWCCRR & send to the Event Secretary: Lynn Kaemmerer, 1 Glenridge Dr., CO. 80123

ENTRY FEE WILL NOT BE REFUNDED in the event of errors or in the event that a dog is absent on the day of the test, disqualified, excused by judges or barred from competition by the test committee, unless an alternate exhibitor is present and willing to take the spot of the exhibitor. Any exhibitor who wishes to withdraw, for any reason, AFTER the closing date but BEFORE the running of the test may withdraw their entry and receive full refund of the entry fee PROVIDED that such withdrawal is made by phone, in writing, by email (valid only if you receive a confirmation e-mail from the secretary) or in person to the Test Secretary PROVIDED that alternate exhibitors are available and willing to take the spot of the exhibitor withdrawing the entry. If, because of storms or other acts beyond the control of the test committee, it is impossible to open or complete this event, no refund of entry fees will be made. PWCCR does not agree to arbitrate claims as set forth on the Official AKC Entry forms for these events.

BITCHES IN SEASON MAY PARTICIPATE. The owner of a bitch in season MUST notify the Test Secretary prior to drawing for tracks. Such bitch(es) will run only after all other dogs have run in the test the bitch is entered in and must be kept away from the immediate vicinity of the test prior to running.

INSTRUCTIONS

- (Variety) If you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (std, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles & Ruby, Blenheim & Prince Charles), Poodles (toy, miniature, std).
- The following categories of dogs may be entered & shown in Best of Breed competition: Dogs that are Champions of Record & dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
- (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e., age division, color division, weight division.
- A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.
